COURSE OF STUDY OF THE LEGAL SYSTEM OF GERMANY

The Dutch speaking Brussels Bar (NOAB), organizes together with the Deutscher Anwaltverein (DAV) a Course of study of the legal system of Germany. This course offers a unique chance to learn about the basic principles of German law. The teachers are exquisite German attorneys or professors, specialised in their respectively area of expertise.

This course consists of 60 teaching hours, dedicated to 10 legal topics.

The course is spread over five modules each of them lasting two consecutive days. The first module starts on 30 and 31 October 2013. The four following modules take place in November 2013, January, March and May 2014. The Dutch speaking Brussels Bar and the Deutscher Anwaltverein will deliver a joint certificate for the effective participation.

The training is oriented towards attorneys, lawyers, managers and students which possess a basic knowledge of German and who get in one way or another in touch with German law or intent to improve their knowledge. The languages used during the courses are German and English. Speakers teaching in German are invited to make an effort in order to speak understandable for non-native speakers.

The first module is a general introduction to the basic principles of German law and German private law. Besides this, six hours are reserved for German legal terminology in order to facilitate the courses that will be taught in German.

As the speakers travel from Germany, the training can only take place when 25 participants register for the full program by 15 September 2013.
